

Covering contract 2021

INSEMINATION ON BØGELUND HESTE

Mares that arrive to the stallion are either accommodated in single paddocks or paddocks with other mares, depending on the agreement with the owner of the mare.

SCANNING PACKAGE

Insemination of the mare is conditioned by buying a “scanning package”.

To follow the mares heat and finding the exact time of ovulation and insemination the mare will be scanned by veterinarian continuously during the heat.

Scanning package includes all control scannings during *one* heat period.

In case of the mare don't become pregnant in the same heat period, a new scanning packages is required.

The owner of the mare can arrange pickup after finished insemination and can arrange pregnancy scan at home on the 15th to 17th day after last insemination.

The owner of the mare can also choose to let the mare stay at Bøgelund Heste, until the pregnancy scan have been completed.

Notice that pregnancy scan is not included in the “scanning package”. (*See the price for “Scanning package” under the section “Payment terms”*).

The owner of the mare pays for all costs associated with the mare. Veterinary bill is invoiced directly to the owner of the mare.

RISK

The mare's stay on Bøgelund Heste is at the owner of the mare's own risk and payment. Bøgelund Heste disclaims all liability in the event of illness, injury or accident. The owner of the mare is fully aware that the mare is not covered by Bøgelund Heste's insurance during the stay.

Should there be a need to call a veterinarian during the mare's stay, the owner of the mare accept by signing this contract, that Bøgelund Heste can call a veterinarian.

Does the mare show life-treathning illness or injury, Bøgelund Heste is no matter what entitled to call a veterinarian. Expenses for this are payed by the owner of the mare.

DEFICIENCIES

Deficient pregnancy when using semen or deficiencies in the mare's foal, doesn't mean that the uses semen or the insemination are deficient.

Bøgelund Heste bears no risk or responsibility in the event of the mare's sudden death, deterioration, contractual injuries the like both during and after the stay, insemination and pregnancy.

ARRIVAL

By arrival at Bøgelund Heste the owner of the mare must be able to document that the mare does not have an infection in the uterine and that the mare have had a new test for CEM, which is negative.

Mares will only be received for insemination if they come from stables where the owner of the mare can declare that there is no outbreak of any contagious diseases.

COLLECTION OF FROZEN SEMEN

Frozen semen is handed out in a semen container. We recommend getting a semen container which is suitable for transport. You can get it at your own Vet.

Semen container can be rented from Bøgelund Heste against a deposit. The deposit is 675 EUR. (+ VAT) plus a daily rent at the amount 7 EUR. (+VAT) pr. Day. The deposit, set of the daily rent, is repaid when the semen container is returned to Bøgelund Heste.

Notice that we do not send frozen semen over bord.

Payment terms

Payment of first rate is due at the first insemination.

Second rate is due 30 days after last insemination (valid in 2021), if there is no negative pregnancy scanning from a veterinarian.

The owner of the mare is obliged to inform Bøgelund Heste (lacour1981@gmail.com) if the mare is not pregnant. The price does not include certification of the covering to The Danish association of Icelandic horses.

PRICES

- **First rate: 270 EUR. (+ VAT)**
the price includes insemination a material costs until a positive pregnancy scanning is achieved or until the end of the covering season 2021 (end of August 2021)
- **Second rate: 950 EUR. (+VAT)**
Due 30 days after the first insemination (valid in 2021) as long as there is no positive pregnancy scanning. The owner of the mare is obligated to inform Bøgelund Heste if the mare is not pregnant.
- **Scanning package 270 EUR. (+ VAT)**
Invoiced directly from the veterinarian.
- **Accommodation pr. day: 10 EUR. (+ VAT)**
First rate and accommodation are due before the owner collect the mare from Bøgelund Heste.

- **Import/Export health certificate**

When entering or leaving the Danish border it is required, that the horse have a health certificate from the national department of Veterinary.

When entering the Danish border from Germany, there must be a health certificate from the Amttierarzt that is no older than 48 hours.

When leaving the Danish border, we will provide the mare with a health certificate from the Danish Veterinary and Food department made by an official veterinarian from that department.

The health certificate must be maximum 48 hours old and cost around 134 Euro that will be invoiced to the owner of the mare.

PRICE FOR COLLECTION OF FROZEN SEMEN

The price for collection frozen semen is 490 EUR. (+VAT). This is payment first rate. The price includes delivery of 1x3 portions of frozen semen for the same mare in the 2021.

The second rate which is 950 EUR. (+VAT) is paid 30 days after delivery of the frozen semen, if there is no negative pregnancy scanning from a veterinarian.

The owner of the mare is obligated to inform Bøgelund heste if the mare is pregnant or not.
